In this study, we sought to find out if there's a correlation between the reading ability of students and their academic performance. We the researchers will undergo many processes so that we can answer the questions regarding the topic. We will determine the level of reading ability and reading comprehension of the students, and if there is a significance difference between the reading ability and academic performance of the students.

It was noted that mostly from Male students who are having difficulties in reading. There are Thirteen (13) males who got the score Twenty (20) below.

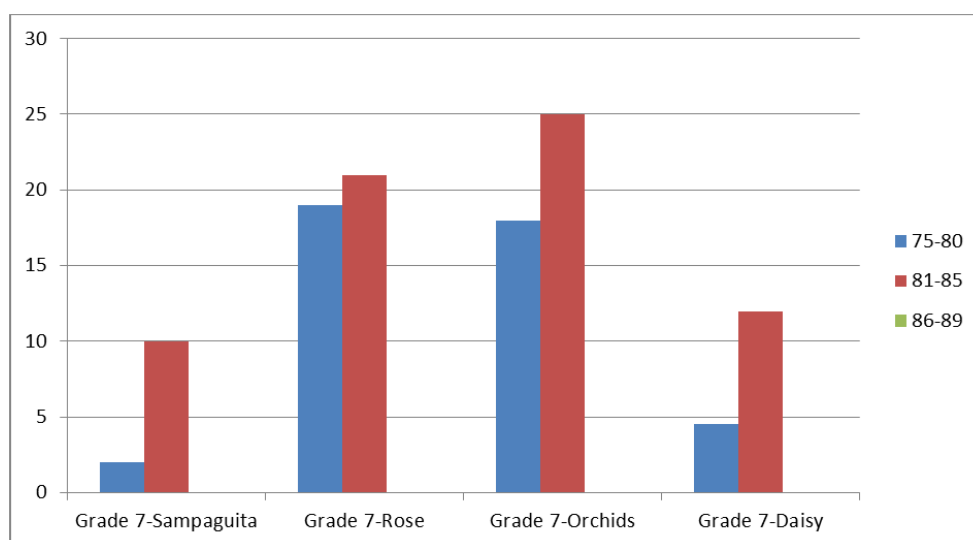


Figure 1. Academic performance of Grade 7-students.

The chart shows the range (average) of the students in their academic performance. In total, it was stated in the chart above that there are 34 male students who got the General Average (GA) of 75-80, compare to the female who have 25 students who got the 75-80 GA. So far, there are 3 female and 2 male students' respondents who got the highest General Average of 85 point something.

3.1. Findings

- 1) There are 38 female students who got the Fast/Independent level.

- 2) Thirteen (13) Male students who is at Frustration level in reading.
- 3) Mostly male students who are having difficulties in reading.
- 4) There are 34 male students whose General Average is 75-80.
- 5) 5 students who got the highest average of 85.
- 6) Reading ability affects academic performance.
- 7) Academic performance can't affect reading ability.

3.2. Conclusion

- 1) After having our analysis and findings we conclude that:
- 2) Male students are mostly having difficulties in reading.
- 3) There are 38 female and 28 male respondents who is Fast learner.
- 4) Respondents who have a general average of 75-80%.
- 5) 68 respondents who has a general average of 81-85%.
- 6) Good reading habits and good academic performance should be balance.
- 7) It is important to have a good reading ability to get a high academic performance.

3.3. Recommendation

In this study, we recommend the following:

- 1) Students should focus in there study and continue learning.
- 2) School administration should take an action regarding the problem of reading difficulties. If school cannot take an action, the academic performance of the Grade 7 students will retain until they reached to higher grade level.
- 3) School administration should ensure that library resources for students is available.
- 4) Parents should guide their children in terms of their reading ability.
- 5) Student should learn to develop and manage their time properly.
- 6) Other researchers should continue in investigating the Reading ability of the students in the school not only in the Grade 7.
